



Intelligent Document Bundling Software

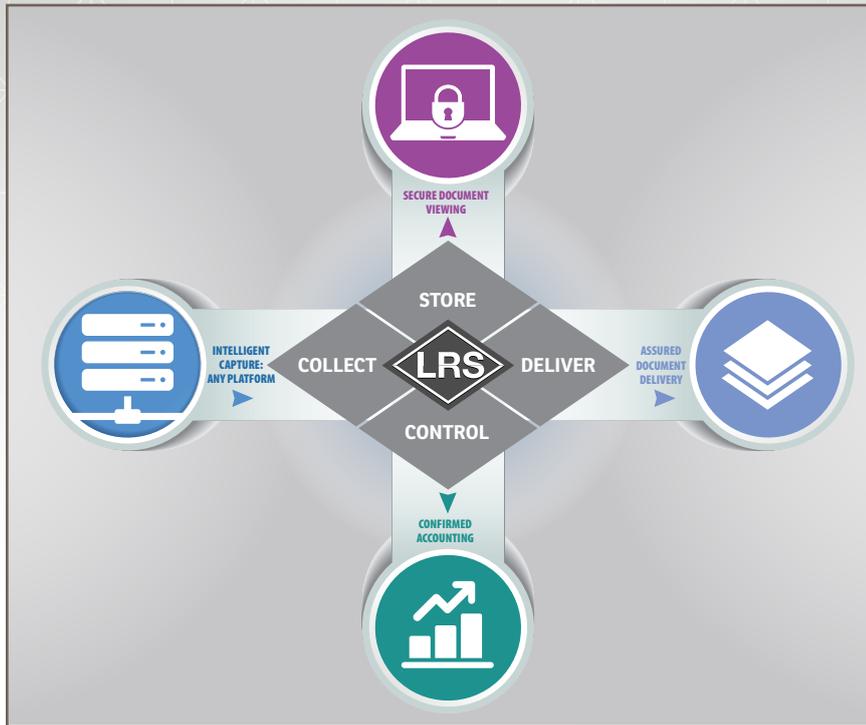

The input documents can reside in any location and be in multiple formats. With IDB software, you can automate document processing and eliminate the risk of errors caused by manual document handling.

IDB software enables you to:

- Retrieve documents from any repository, file share, or web location
- Sequence documents in the right order
- Transform and merge multiple data sources into a single document format

- Enhance documents with dynamic content such as overlays, barcodes, variable text, etc.
- Deliver documents to single or multiple destinations
- Monitor and control documents to ensure delivery



The Enterprise Output Server collects documents from Windows, UNIX, Linux, mainframe, and other platforms and makes them available to stakeholders throughout the organization in hardcopy and electronic form.
